OFFICERS AND COMMITTEE REPORTS - 03/16/2011

Treasurer - Kildine Harms

- February financials, year to date vs. last year, are attached.
- Last week a new OW trailer was purchased for \$2,687. There will be additional cost for DMV registration and
 inside set up. During the review of the Budget \$3K was in the suggestion column for new trailer, however,
 the budget only include \$1K for re-painting. Although it has already been done, we should approve an over
 budget expense of \$3,000.
- Michael suggested that we revise the mileage reimbursement for our volunteers. The current IRS optional standard mileage rates are 51 cents per mile for business miles driven and 14 cents per mile driven in service of charitable organizations. I would like to propose that Pacific Master mileage reimbursement be 40 cents

Vice Chair Operations - Jim Clemmons

With Jody Smith on travel during this particular meeting (to Mesa for Nat's pre-meet status update/review), John Morales and I will be announcing the Pacific Masters Coach of the Year selection. The COTY Committee, Jody (lead), John and I, made our selection during the months of January and February. We had proposals from teams for two Head Coach candidates and a group of Assistant Coaches from a third team from which to make our selection. It was a challenging decision; all of the candidates were very deserving of the award.

Registration - Nancy Ridout

As of 3/14/11, we have registered 7,849 swimmers and 122 clubs. We welcome the Ukiah Dolphins (UD) to Pacific Masters. Past history shows the comparable figures at this point in the year to be: 7,523 swimmers and 116 clubs as of 3/16/10; 7,020 & 119 clubs as of 3/18/09; 6,280 & 114 as of 3/11/08; 6,117 & 99 as of 3/16/07; 5,564 & 95 as of 3/10/05; 5,654 as of 3/15/04; 5,521 & 107 as of 3/14/03; 6,791 and 104 as of 3/22/02; 6,187 & 113 as of 3/28/01; 5,922 & 101 as of 3/18/2000; 5,809 & 95 as of 3/19/99; 5,211 & 92 as of 3/20/98; 4,949 & 91 as of 3/26/97; 5,038 & 100 as of 3/27/96; 4,253 & 81 as of 3/17/95; 4,698 & 82 as of 3/18/94; 4,155 & 84 as of 3/20/93.

Top Ten and Records - Nancy Ridout

The Swimmer of the Year tabulations has been completed and are here for your approval. We will nominate and vote on the overall male and female swimmers of the year. Anyone can nominate a swimmer and will have 2 minutes to speak on behalf of him or her. We will vote by secret ballot.

Meet Operations – Barry Fasbender

San Mateo Masters LCM Meet. We have added a new LCM meet on Saturday, June 25 or Sunday, June 26. The meet will be held at the San Mateo Athletic Club located at the College of San Mateo. The new pool complex has a 50 meter Olympic pool and a 25 yard instructional pool. There will be 100's and 200's of each stroke plus the 200 IM and 400 free.

Rinconada Masters SCY Spring Meet. We had our best weather in several years for this meet, which was enjoyed by 239 swimmers who swam a total of 795 events not including the 1650 Fly.

Coaches - Cokie Lepinski

2011 Pacific Masters Excel Weekend Clinic

The committee working on the June 10-12 coaches' clinic has named this clinic: Pacific Masters Swimming *Excel Weekend*. Our budget is very much in flux as we are awaiting word from the College of San Mateo on facility changes, etc. We are basing our numbers on the goal of 40 coaches and 50 swimmers attending the clinic. With no charge for the coaches, and a \$130-\$150 charge for swimmers (\$130 early reg, \$150 late reg) we anticipate a revenue of a little over \$6000 and expenses <u>currently</u> estimated at \$16,000.

Our website should be up and running with very limited information this week and possibly fully operational in the next 2-3 weeks. We are working with Club Assistant to prepare an online registration portal.

We request that our clinic take up a prominent spot on the home page of Pac Masters website and be published regularly between now and the clinic date in the Constant Contact e-newsletter. We need to get the word out now about our clinic.

Also, looking for information on how we present insurance information to the hosting facility.

SWIMFEST '11

USMS is holding SwimFest '11 in Atlanta, Georgia, May 20-22. I'd like to propose that we offer a flat scholarship of \$500 for up to 5 Pac Masters coaches to attend. That will cover a coach's flight and perhaps one night of a hotel stay. Total cost would be \$2500. At this point I've had one coach enquire whether we were offering any type of scholarship.

Open Water - Glenda Carroll

The Open Water Events Directors' meeting was held on February 27. Along with discussing the rule changes for 2011, the majority of the meeting was focused on open water safety. Jim Wheeler, past OW chair and safety expert, and Kevin Lennon, last year's event director at Whiskeytown, both gave presentations. Excellent discussion followed.

Because of the safety concerns, one popular open water swim, Lake Sonoma 2 mile swim, has cancelled the event for this season. They want to make sure they have the support needed from both local EMS and the Army Corps of Engineers and are not sure they can meet with both groups before their announced swim date. Lake Sonoma was to be the OW 2011 championship. The OW Championship will now be Russian River 1 mile swim on Saturday, July 16.

Further Discussion Needed: Current Pacific Masters Handbook does not require an ambulance on site. We may want to revisit this and for next year potentially raise entry fees so sponsoring clubs can pay for ambulances (about \$500).

Allan Cartwright, the trailer guy, was recognized for 10 years of outstanding service. He was given 2 tickets to SF Giants/LA Dodgers game in July.

A new bigger open water trailer was purchased this week. Also purchased were 8 lifeguard rescue tubes. We will be purchasing 4 paddleboards to be used at the open water swims.

Communications

Newsletter - Joanne Berven

The May-June issue of the newsletter is ready to go, except for Michael's message and the fact that I have not heard back from Tom Pokorny about deadlines. I wrote him over a month ago asking and he replied that they would be coming shortly. I still have not heard from him and emailed earlier this week.

Web Master - Michael Moore

In the past month three Updates have gone out to the membership, a welcoming letter went out to 862 members. Currently there are 13,800 people on the email list. Constant Contact allows us to track the number of people who "open" the email blast. For the Update, there is a consistent rate of about 25% of the membership "opening" the email.

A new template for the Update was developed, the new Update template will go out with the next Update. There is a change in the base colors of the email, along with the new logo.

The website has been averaging about 126MB of data transfer per day. The last two Sundays have had the most bandwidth of the week, which is very unusual as in the past it has been the lightest day of the week. (Maybe swimmers are checking the web page since football and baseball are not being played.)
