I've received correspondence and a request from Scott Patterson regarding the Cruz Cruise OW event who feels an ambulance is an essential safety component for this swim. His request is below.

I was pleasantly surprised that our most local ambulance service charges \$125 per hour for a "dedicated" ambulance, which includes two EMT's. The Cruz Cruise 2 Mile each year can just about count on >having 85 or so participants. By spreading out our big item costs, we have made as little as \$800, and as much as \$1800, depending on what we have had to pay for labor, what we could charge as an entry fee, etc.

We believe the CC2M fills an important niche in the PMS Open Water lineup each year, and have enjoyed doing it now for 15 years or so. It continues on as a race that isn't for everyone...the cold water, variable conditions, and two mile length excludes us from expanding the # of participants by allowing youngsters and we've never wanted to consider "one-day-memberships", but always encouraged the wearing of wetsuits (especially the first time attempting the race). We historically rode the coat-tails of the Pier to Pier Swim ambulance-wise, when we ran our race simultaneously, shared the finish line, and volunteer staff, etc. More recently, we have relied on our lifeguards to supply EMT staff, but after the Whiskeytown tragedy, if at all possible, we want to make sure we can cover every conceivable safety concern.

We are requesting that PMS subsidize the cost of a dedicated ambulance, which should be about \$375 (8:30 AM to 11:30 AM). Please include this request in the June 15th meeting's agenda...and let me know if there is more I can do, to answer any questions, field comments, etc. (831) 706-7950

Proposals by Michael Moore from May meeting

To Strike

202.1.1.D d No sanction may be issued to any organization whose interest in sports and games is purely commercial, or where the event is to be promoted solely for the profit or the advertising value to be derived therefrom. Any income derived from sanctioned events must be used for the general welfare of the promoting organization as a whole.

Recommend that this section be stricken from the Rule Book. We should encourage people and organizations to organize meets for swimmers. More events would benefit the swimmers. Currently we hire professionals to run certain part of the meets, but they do not take the risk and are assured of their money. If we allow professionals to organize some meets we would have these professionals running the meet and taking the risks.

Change the Liability Release from

"I, the undersigned participant, intending to be legally bound, hereby certify that I am physically fit and have not been otherwise informed by a physician. I acknowledge that I am aware of all the risks inherent in Masters swimming (training and competition), including possible permanent disability or death, and agree to assume all of those risks. AS A CONDITION OF MY PARTICIPATION IN THE MASTERS SWIMMING PROGRAM OR ANY ACTIVITIES INCIDENT THERETO, I HEREBY WAIVE ANY AND ALL RIGHTS TO CLAIMS FOR LOSS OR DAMAGES, INCLUDING ALL CLAIMS FOR LOSS OR DAMAGES CAUSED BY THE NEGLIGENCE, ACTIVE OR PASSIVE, OF THE FOLLOWING: UNITED STATES MASTERS SWIM- MING INC., THE LOCAL MASTERS SWIMMING COMMITTEES, THE CLUBS, HOST FACILITIES, MEET SPONSORS, MEET COMMITTEES OR ANY INDIVIDUALS OFFICIATING AT THE MEETS OR SUPERVISING SUCH ACTIVITIES. In addition, I agree to abide by and be governed by the rules of USMS."

To

"I, the undersigned participant, intending to be legally bound, hereby certify that I am physically fit and have not been otherwise informed by a physician. I acknowledge that I am aware of all the risks inherent in Masters swimming (training and competition), including possible permanent disability or death, and agree to assume all of those risks. as a condition of my participation in the Masters swimming

program or any activities incident thereto, I hereby waive any and all rights to claims for loss or damages, including all claims for loss or damages caused by the negligence, active or passive, of the following: United States Masters Swimming Inc., the local masters swimming committees, the clubs, host facilities, meet sponsors, meet committees or any individuals officiating at the meets or supervising such activities. In addition, I agree to abide by and be governed by the rules of USMS."

The only change is that we change all capitals to bold face. It has been shown in tests that All Capitals are more difficult to read than upper and lower case. By changing to upper and lower case we make it easier to read and we bold face to indicate its importance.
