Coaching Clinic Reimbursement Policy 2012

Pacific Masters Swimming strongly believes that coaches are vital to the success of its swimming programs and as such emphasizes continuing education for coaches. Two educational clinics that are sponsored by the American Swimming Coaches Association (ASCA) and targeted by Pacific Masters, are the ASCA Napa clinic, held early in the year and the ASCA National or World clinic, generally held around the September timeframe. These two clinics are addressed annually by Pacific Masters during the budgeting process and allowance for attendance with some minor stipulations are published for the coaches consideration to attend one or both clinics.

In addition to the two targeted clinics held annually by ASCA, there are additional opportunities for clinic attendance. For clinics beyond the Napa and World clinics, Pacific Masters will reimburse up to \$200 of the clinic fees and 50% of travel expenses to the clinic. Travel reimbursement will be limited to \$200. Reimbursement is limited to expenses for one clinic per coach per year beyond the two targeted clinics and will not exceed \$5,000.00 for all of Pacific Masters.

Over the last few years the Board has made a number of policy decisions like the one above that were not included in the Guide to Operations. Please send me any such policies that you are aware of. Unless someone else volunteers, I will compile and maintain the list.

Request vote on whether Pacific Masters should take out an ad in the May June issue of Swimmer magazine. Ad would remind Pacific Masters members that the Pacific Masters newsletter is now distributed electronically and members without internet access can request paper copies. Cost is approximately \$1000 (70% of \$1,370).

I have asked everyone who is responsible for a Pacific Masters Essential Operation to create a backup plan for important files and records along with some simple documentation on the operation.

Coach of the year selection committee to be announced at meeting.

I am trying to schedule a meeting of the ad hoc communications strategy committee. This committee will make recommendations on what and how Pacific Masters should be communicating. Committee members are: Michael Moore, Joanne Berven, Caroline Lambert, Rich Burns, Nancy Ridout, Deborah Newton and 1 to 3 younger members of Pacific Masters. If you have opinions on our communications strategy, please send them to Rich Burns and me.

I would like to create a database containing information on club-pool relationships (cost parameters, practice times, etc). Would any board member like to take this on or does any board member know someone who has the skills and interest to take it on?

The Open Water Event Directors yearly meeting will be a conference call on Sunday, February 26, 2012.

The 2011 OW first place winners in the points competition – both Cat A and Cat B – have been notified that they have a won a swim suit designed by "Q". I have attached a copy of the art work. The swimmers who have responded so far with their suit size and mailing information are very excited about the suit. I plan to

put in a group order the first week of March. The suits should be delivered to me by early April. I will send them to the winners.



USMS Open Water Committee – Online applications for sanctioning are being eased in this year. An event director will fill out the online application at USMS (very similar to the application we already have) and then I will receive notification of it. I'm trying to develop a way to interface with the online applications that won't cause our event directors extra work.

Meet Operations - Barry Fasbender

Quicksilver SCY Meet. The Meet Info for the Quicksilver SCY meet on Saturday, April 21, 2012 is posted on the PacMasters website. This is the first time this team is hosting a meet. They are offering a large number of events: four 50's, five 100's, two 200's, the 500 and 1650 free, and the 200 free and medley relays.

Event Results and Rankings. The results for the TOC, FOG City, and USF meets have been uploaded to the USMS Event Results and Rankings database.

New Online Event Sanction Request Process. The USMS End-to-End Event Management task force launched an enhanced on-line calendar of events, which also includes a new online sanction request system. The mission of the task force is to provide full tracking of 100% of our events (pool and open water) in our database, from listing them in the calendar to tabulating the results. Sanction chairs have been requested to instruct event directors and hosts in their LMSC to begin using the new online tool to request their event sanctions and recognitions.

Registration - Nancy Ridout

Pacific Masters has registered 7,793 swimmers and 120 clubs as of February 14th. Past membership totals for a similar date are as follows: 7,303 swimmers and 121 clubs as of 2/15/11; 6,853 swimmers & 114 clubs as of 2/16/10; 6,429 & 115 as of 2/14/09; 5,684 & 113 as of 2/11/08, 5,437 & 97 as of 2/16/07; 5,337 &102 as of 2/11/06; 4934 as of 2/10/5; 4,951 as of 2/14/04; 4,998 & 102 as of 2/14/03; 5,414 & 104 as of 2/16/02; 5,166 & 111 as of 2/23/01; 4,752 & 95 as of 2/18/00; 4,466 & 87 as of 2/5/99; 4,482 & 89 as of 2/25/98; 4,432 & 87 as of 2/21/97; 4,366 & 93 as of 2/23/96; 3,911 & 83 as of 2/22/95; 3,776 & 79 as of 2/23/94; 3,722 & 80 as of 2/19/93; 3,867 & 71 as of 2/21/92. Two potentially new clubs have requested information to register a club.

A message was sent out to each club announcing the change in our newsletter distribution and requesting the names of any members who might need a paper copy because of no access to the internet. Several clubs responded that they knew of no members that couldn't read the newsletter online. None responded with any names.

Top Ten and Records - Nancy Ridout

The USMS SCM Top Ten was sent out and proofed to be sure all eligible Pacific Masters were included. Laura Val brought to my attention that her 1500 splits were not shown on the USMS Top Ten. I contacted USMS and those times, as well as that of Tim Broderick, were added. We are not sure what happened. SCY Pacific Masters Records are posted and LC and SCM will follow shortly, along with the Top Tens for 2011. Points for the 2012 Age Group Swimmers of the Year will be tabulated and the winners announced at the March meeting.
