<u>Registration</u>: 11,214 members; 153 clubs; 469 self-identified coaches have registered for Pacific Masters as of 8/12. In 2016 we had 11,427 members; 149 clubs; 427 coaches at this time. Top Ten: SCY top 10 finalized by USMS.

<u>Records</u>: all SCY records are up to date on the PacMaster website. Pacific records from the LCM Championships have been updated. Five UMSM and Four world records were submitted to the USMS Records Administrator.

<u>Swim Events</u>: All High Point and Team Awards from the LCM Championships were mailed last week, OEVT paperwork from Del Valle OW Festival and Santa Cruz OW Weekend have been received. DAM End of Summer Splash results are posted but the paperwork has not been received. Chris will be on vacation from August 17 to August 22.

### **Schedule**—Steve Cutting, report

- The following is a correction to championship meet event time frames (per Pacific Masters guidelines) presented in the July meeting:
  - The Short Course Yards Pacific Masters Swimming Championships <u>should</u> be held no earlier than 3 weeks prior to the Short Course Yards Nationals. 2018 Spring Nationals are scheduled for May 10 13 in Indianapolis, IN. This would make <del>potential</del> the last possible weekend dates of: (Fri-Sat-Sun) April 20-21-22, <u>April 27-28-29</u>, and <u>May 4-5-6</u>. Another consideration for this meet, if it will be held at a High School, is that it be scheduled during their Spring break. this could push the dates earlier in April.

- 2. The Long Course Pacific Masters Swimming Championships <u>should</u> be held no earlier than 3 weeks prior to the Long Course Nationals. The 2018 Summer Nationals have not been awarded at this time, in favor of supporting the Pan American Championship in Orlando: 2018 Pan American Championship are scheduled for July 28 August 3 in Orlando, FL. This would make <u>potential</u> the last possible weekend dates of: (Fri-Sat-Sun) July 6-7-8, July 13-14-15, and July 20-21-22.
- 3. The Short Course Meters Pacific Masters Swimming Championships *shall* be held in the Fall of the year. This would make potential weekend dates of: anytime after September 20. For the past several years, WCM has run this meet on the 2nd weekend in October, which will be (Fri-Sat-Sun) Oct 12-13-14 this year.

It was decided at the June meeting that the board would vote on these proposals at the August meeting. Here is the first proposal:

Proposal: (Details and examples of this proposal are here:

#1: I'd like to propose that, for the purposes of computing everyone's placement in the new Age Group Standings, that we declare everyone's Age Determining Date to be December 31st of the season year. The basic reason is that every year approximately one-fifth of our swimmers have their Age Group Standings points split across two age groups, making it difficult for them to compete with others in their age group. This affects every one of us every 5 years. For example: consider PAC member Anna Senko: Her birthdate was May 4, 1992. For the 2017 season she's in the 18-24 age group up until May 3rd of 2017, after which time she's in the 25-29 age group. She has already scored points in both age groups. However, if we considered her age for the entire 2017 season to be her age on December 31, 2017 then she'd be in the 25-29 age group for the entire 2017 season. Thus all of her points would be applied to that one age group.

## Proposal:

- #2: I'd like to propose that for the purposes of determining the Swimmer of the Year and final Age Group Standings for a season we establish the cutoff date of the first Monday following March 1 of the following calendar year. For example, the cutoff date for the 2017 season will be March 5th, 2018. This cutoff date is used for the following:
  - On this date we will get a final set of all PAC and USMS top 10 results and records for the season. (It's assumed that the season's open water results were finalized prior to this date.)
  - On this date we will get a final copy of the PAC membership database for the calendar year for the season.
