Officials — David Benjamin, report \*

Good evening, all. I'm proud to succeed Mike Abegg as your Officials Chair. Thank you for trusting me with this appointment.

There are two subjects I'd like to bring to your attention, with proposals for action by the Committee.

#### REIMBURSEMENT OF PACIFIC OFFICIALS WHO WORK NATIONAL MEETS

Our Administrative Handbook addresses the issue of reimbursing PacMasters officials who work at Nationals, but the Handbook, our budget and our practices are out of sync.

The Handbook provides that one Pacific official shall be selected to work Nationals, and that Pacific will pay that official's travel expenses (travel, hotel, meals). I believe we have budgeted \$1,000 for both Spring and Summer Nationals. This year, however, five Pacific officials traveled to Irvine voluntarily and worked the meet. There was no particular selection process for any one official that I'm aware of. While the budgeted amount of \$1,000 may be sufficient to pay the expenses of one official traveling to Irvine, it is definitely not enough to cover all five, much less to cover travel to Florida for Summer Nationals..

I think it's important for Pacific to support our National Championships; plus, working high level meets provides valuable experience for our officials, who then bring that experience back to our LMSC meets. The only issue, at least in my mind, is the level of financial support Pacific should provide to its officials.

There are lots of ways to address this. To me, what's important is to have a process that encourages officials — not just one official — to go to Nationals; a process that's clear and easy to administer; and a process that does not impose all of the financial burden on PacMasters - USMS provides some financial assistance, and I believe that we as officials should bear some of the cost, too.

## Proposals\*

- 1. Spring Nationals at Irvine: It is my understanding that all of our officials who worked this meet have applied to USMS for financial assistance, and that if PacMasters allocates another \$1,500, we will be able to reimburse these officials an additional \$500. I propose that we amend the budget to allocate an additional \$1,500 to reimburse these officials.
- 2. Going forward: I propose that we amend our Handbook and our budget to provide that we will reimburse our officials who work Nationals for their reasonable travel expenses (travel, hotel, meals) not to exceed \$1,000 per official. To be eligible for reimbursement, the official must work at least three days at Nationals; must request reimbursement from USMS before seeking reimbursement from PacMasters; and must submit appropriate receipts to PacMasters.

#### DELAYING HEATS TO CALL FOR MISSING SWIMMERS

Michael Moore and John King have called my attention to a Pacific Swimming Standing Policy, adopted in 2014, which <u>requires</u> deck officials to call at least once for any missing swimmer. This is a time-consuming practice: it takes 20-30 seconds to call for missing swimmers. Over the course of a meet with 100 or more heats, calling for missing swimmers can add significantly to the timeline. At some meets, particularly pre-seeded meets, this unnecessarily prolongs the meet.

I propose that <u>Pacific Masters policies</u> be amended to read as follows:

There will be at least one (1) call for no show swimmers at Pacific Masters sanctioned meets. Each swimmer not present following the short series of whistles will be called by name and lane assignment. The number of calls will be determined before the start of the meet and consistently maintained throughout the meet. The meet referee, in her/his discretion, shall decide whether to call for no show swimmers at Pacific Masters sanctioned meets, and shall inform the coaches of her/his decision at the coaches meeting before each session. Under no circumstances shall the

<u>referee decide to make more than one call for no show swimmers. The referee's decision shall be</u> consistently maintained throughout the session.

- 3. Eight Bridges Virtual Event 2023
  - Event Director: Rebecca FriedlanderEvent dates: June 1-September 30
  - From Rebecca:
  - The inaugural Eight Bridges Virtual Swim kicked off June 1. Currently, 54 solo swimmers are on the course as well as three relays. There are swimmers from six different states (AZ, CA, CO, HI, OH, NV). Of these, California (especially the Bay Area) is predominant with Livermore registering the most (16) of any team/club. Most common cited advertising sources include: "friend," Odyssey OW, PacMasters website, South End Rowing Club/Zina, and "team email." Participant issues have been minimal, the most common questions are, "how do I log my swim?" (they did not find/save their event email which includes their personal log in link, simple enough to re-send) and "why aren't my swims showing?" (all of which from relay members who did not designate their relay when registering). Thank you emails from swimmers and coaches have been rolling in as well -- they're happy to have "something fun to do" this summer, are finding the yay bridges! emails fun and interesting, and are using the event as a team challenge. 15 t-shirts have sold to date; we need 48 sales to have a print run.
  - 4. Open Water---Aggregate challenge: Working to create recognition levels for total successful splashes from 2021 forward.
  - 5. At the USMS Annual Meeting last fall, the House of Delegates voted to accept an increase in 2023 membership dues. This included an increase in the OEVT fee from \$15 to \$20. Chris has very helpfully sent out the following to our upcoming hosts: The Pacific LMSC has decided we will only charge our events host \$15 of the \$20 USMS OEVT fee. We did this with Berryessa and have offered it to Del Valle. We'll offer for Santa Cruz, Whiskeytown and Keller Cove too (Donner doesn't have OEVT). As event hosts, you can choose to pass that savings on to your swimmers. If you do pass this savings on, I would ask, however, that somehow you word it in the info sheet so that the OEVT swimmers know that Pacific Masters is underwriting some of their fee. FYI, Berryessa didn't pass it on because they didn't know in time. Del Valle is planning on passing the reduced fee on to the swimmers.

#### BAPPOA Membership

#### Lifeguard Training for Masters Swim Coaches \*

Our Coaches Committee recognize the importance of supporting our coaches in various ways. After thoughtful deliberation, the committee determined that one valuable initiative we can undertake is to facilitate lifeguard certification for our coaches. To make this process more accessible, we agreed to cover at least 50% of the course instruction fees, limited to a total of 10 coaches.

Proposal: I propose Pacific Masters allocate an additional \$1500 for Coach lifeguard training. Each coachw ould be eligible for \$150 scholarship toward the course; each coach would need to be a USMS certified coach; each coach would need to be actively coaching a Pacific

Masters club.

We reached out to Tracy Newman, President of BAPPOA, to coordinate a lifeguard certification course specifically tailored for the coaches of Pacific Masters Swimming. Training is 20 hours in length and can be scheduled in different ways. For example:

- 1) Friday-Sunday. Friday: 4-8pm, Sat & Sun 9a-6pm
- 2) Friday-Sunday. Friday: 4:30-9pm, Sat & Sun 8:30am-5:30 pm
- 3) Monday-Thursday. Each day, 10am-6pm
