The executive committee under the direction of our Treasurer is preparing the budget for the next year. If you have any questions or an idea, please contact the responsible executive committee member.

Congratulations to the Pacific master's members who competed in the USMS Nationals in Sarasota and the World Aquatic Masters championships in Japan. There were several world records set especially by Laura Val, Rich Burns, and the TAM relays. Great swimming everyone.

I am working on the criteria that will be used to select the Pacific Masters members to attend the USMS Relay meeting in October. The Executive committee will make the final decision. We have several members who will be involved in the meeting presentations. The following suggestions on criteria was sent from the USMS National office:

The theme of this year's Relay is event development, with a focus on building relationships with event directors, clubs, and aquatics facilities. LMSCs should select attendees who have the interest, skills, and passion for working with these groups or are a part of them. To prepare for Relay, we recommend that you spend the next few weeks finding the volunteers in your LMSC who are the most involved in putting on events and persuading them to attend.

We recommend LMSCs send at least one long-time volunteer, one volunteer who runs an event, and one volunteer who has never participated in a USMS national-level meeting.

If you want to attend, please send an email to Chris Ottati and myself. I would love to see some of our current in person event hosts attend. You may be selected if you will consider hosting an in person event in the next year or two.

- <u>Registration</u>: 9,537 members; 115 clubs; 556 self-identified coaches have registered for Pacific Masters as of 08/15/23. In 2022, we had 9,931 members; 117 clubs; 954 selfidentified coaches.
- 2023 USMS Annual Meeting: For all delegates USMS is continuing to update the webpage for the 2023 Annual Meeting. Make sure you keep checking it and use your SCHED login to sign up for forums and meetings you'd like to attend. I sent an email out to delegates with detailed information on 8/9.
- <u>Administrative Handbook:</u> The Administrative Handbook has been updated with the Officials' National Championship reimbursement policy that was approved last month.
- <u>LCM Championship</u>: The Team high point awards have been sent out. The individual high point awards should be ready to be sent out shortly.
- <u>Relay 2023:</u> I have been preparing for Relay 2023. I am part of the lunch panel showcase (with Teddy) and one of the leaders of the Community Building Events session.
- <u>Bylaw changes:</u> Per our bylaws, any bylaw changes must be voted on at our Pacific Masters Annual Meeting (to be held November 12, 2023 this year). One can read all about it in our <u>Administrative Handbook</u>. Proposals for changes, amendments, repeals, etc must be made in writing to a board member 45 days before our annual meeting and this committee must be notified 30 days prior to our annual meeting. It was brought to our attention by David Brancamp months ago that we will need to make a change to section 103.4.1 and 103.4.2 of our bylaws. These sections deal with membership fees and with the advent of USMS's Unified Fee our bylaws are no longer accurate. I will propose the following changes:

103.4 Membership and Fees

- Club Every Member Club joins Pacific Masters Swimming and USMS by submitting an approved application and by paying an annual fee consisting of a national club fee established by USMS and a local club fee established by the Pacific Masters Swimming. a national club fee and a local club fee, both established by USMS.
- 2. Member Registration Each Member submits a registration application and pays an annual fee consisting of a fee established by USMS and a fee established by the Pacific Masters Swimming Committee. a national fee and a local fee, both established by USMS.

Pool Meet Committee—Matt Roper, report

- Marin Aquatic Masters hosted the 2023 Pacific Masters LCM Championships at the Miwok Aquatic Center from July 21st-23rd.
 - There were 373 swimmers entered (a 20% increase from 2022), representing 43 teams.
 - A huge thank you to MAQ for hosting another excellent championship meet!
- It's time to select our host for the 2024 Pacific Masters SCY Championships
 - We received two hosting bids:
 - Bid from Morgan Hill to host @ the Morgan Hill Aquatic Center, May 3rd 5th
 - Bid from Sac Masters to host @ the North Natomas Aquatic Complex, May 17th 19th
 - Note that the Pac Masters Championships will be held later than usual next year because USMS Nationals is being held later (June 20-24th).
 - After reviewing both bids, the Pool Meet Committee recommends that we accept the bid from Sac Masters.
- The "400 Fastest Pull for Sebastopol" e-postal is underway now and continues through the end of this month.
- The Pool Meet Committee is working on our 2024 budget now. If your team is thinking about hosting a meet next year, we'd appreciate it if you could drop us a quick email so that we'll have a rough idea of how many meets to budget for.
- The development grant subcommittee received a request from the Livermore Aquacowboys (LAC). They are requesting a \$5,000 grant to allow their newly-formed team to break even financially for 2023; they project that by January 1st they should have enough members to become a financially self-sustaining team. The grant subcommittee has reviewed LAC's proposal and their provided financial details and has decided to approve this grant request. We expect the \$5,000 request to be partially funded by USMS, partially funded by Pacific Masters and we're currently working through the details and paperwork

 - The Eight Bridges Virtual Swim has grown to well over 70 solos and four relays with five states and Canada represented. Participant age range spans 19-83. We've seen many solo finishers, as well as three relays complete the course. As such, a "course records" list has been created. An eventual "home" for this info would be helpful, perhaps the Pac website and event home page? Posting these records likely will inspire future entries to chase them! Our shirt sales reached the print-minimum and are slated for delivery. Emails from swimmers continue to reflect their enthusiasm, we've even fielded requests to re-enter the course. Granted for free this year but something to think about for the future: Offer more registrations options such as Solo and Relay, discount re-entering the course to swim as a Solo after completing a relay effort, etc. More and consistent spotlighting would be helpful, there is still time to enter and complete the event as well as drive up enthusiasm.
- 5. Open Water---Aggregate challenge: We have provided categories and an overall description to Bob Upshaw, who is generating recognition for levels of total successful splashes from 2021 forward. Bob has been incredibly helpful and diligent on this as with all things. It would be helpful to receive some spotlighting.
